Members reviewed Member Opalka's email regarding the PUD document and agreed to change all "should" or "may" to "shall" to make the document direct and not so loose.

Member Murphy stated landscaping would be part of a design comprehensive plan.

Member Bucci stated they had previously spoke of two options, one talked about doing a comprehensive plan that would include a landscaping paragraph, or option two it became part of the ordinance.
