# 1. CALL TO ORDER

## 3. DISCUSSION AND POSSIBLE ACTION ON:

#### a. DESIGN GUIDELINES -

Chair Peter Sanborn thanked the members for attending the meeting and did roll call. Members made various comments about several topics on section 3 of the draft design guide. The comments mentioned were a continuation of various comments on topics from their last special meeting.

- Recommended standards- site design, building design standards, lighting standards and parking lot standards.
- Parking side- buildings shall have no more than two rows of street-fronting parking within the setback area. No more than 50% of a site's gross square footage should be used for surface parking. Exception: Does not apply when satisfying min. parking standards
- Removal of trees- requiring replacement per existing ordinance
- Parking garages- shall be located in the interior of the site and concealed by a building wherever feasible.
- Pedestrian Priority areas- How buildings should be oriented to provide access, activity and visual definition; buildings in commercial districts shall provide walkways consisting of various accommodations.

• Building exterior visibility- Key corridor (Will not include any other streets other than Gaylord and I10) -Building facing the promenade shall be no more than 24ft from the street.
